## **ANIMAL RIGHTS**

- Testimony: Marin County Planning Commission, Marin County Board of Supervisors, California Coastal Commission on not poisoning Farallones, Pt. Reyes National Seashore and Development at Muir Beach potential effects on Coho salmonids.
- Laura Chariton, a past four-year Tule Elk docent at Pt. Reyes National Seashore works with activist groups to
  protect the Tule Elk of Point Reyes National Seashore, delivering water and nutrients necessary for their
  survival. Laura is a plaintiff in the Federal Case with other plaintiffs represented by Harvard U. Animal Law.





Interfacing with other organizations is critically important to our success. New and renewed relationships with other organizations: North Coast River Alliance, SPAWN, Shore Up Marin, Sierra Club Marin Group, Sierra Club Bay Chapter and Sierra Club National, Mill Valley StreamKeepers, City of Mill Valley, Marin County Stormwater Pollution Prevention Program, Gallinas Watershed Council, Lagunitas Technical Advisory Group, Environmental Solutions Project, Marin Conservation League, Marin Municipal Water District, Larry Bragman Board member, Frank Egger 5 time Mayor of Fairfax, Mia Monroe, **Community Coordinator for National** Park Service, Resource Renewal Institute, Marin County **Parks** Environmental Round Table, Sierra Club Federal Lands Committee.



Judy and Laura raised over a dozen monarch butterflies and from eggs to caterpillars to butterflies and their obligate milkweed plants. Four caterpillars were relocated to a fecund milkweed habitat in Mill Valley. This year saw a boom in Monarch migrations. Laura raised about 8 Anise Swallowtails earlier in the season.
